I, as the owner, agree to be solely responsible for any and all acts or behavior of my pet while in the care of Happy Hounds. If my pet should become ill or seem to be in need of medical consideration, Happy Hounds reserves the right to administer aid and/or use any available veterinarian. I, the owner, shall pay any expenses so incurred.

I understand that participation in dog training is not without risk to myself and my dog as well as any family members or guests who might attend. I hereby waive and release Pat Marshall and Jim Marshall, their Agents, Happy Hounds Pet Dog Training and the owner/lessor of the facility from any and all liability of any nature, for injury or damage suffered as a result of my participation in any class or private lesson, including any damage or injury resulting from the action of any person or dog, or for any accident occurring on the premises or it's surroundings. Owner agrees that Happy Hounds Pet Dog Training and Pat Marshall will not be liable for any damage or loss resulting from the failure of the dog to respond to any commands taught to the dog by HHPDT or resulting from counseling and advice supplied to owners of dog.
